Tier II Canada Research Chair in Financial Mathematics

The Department of Mathematics invites applications for a Tier II Canada Research Chair position at the level of a tenure-track Assistant Professor or tenured Associate Professor in Financial Mathematics, to commence on July 1, 2015. The position is subject to final budgetary approval.

The desired candidate will show a significant international standing, with evidence of an outstanding research program, grant funding and highly qualified personnel supervision. The successful candidates will hold a PhD or international equivalent in Mathematics or Statistics, preferably with postdoctoral experience, and must demonstrate a strong commitment to graduate and undergraduate teaching and supervision. It will be expected of the candidate to have demonstrated excellence in research and be at the forefront of outreach into the financial/insurance industry, attracting funding and creating productive relations nationwide. We encourage applications from junior to experienced researchers/professionals in the field of financial mathematics. The level of the appointment will be commensurate to the experience of the applicant. All Chairs are subject to review and final approval by the CRC Secretariat. The deadline for receiving applications is December 15, 2014. Review of applications will commence by the end of December 2014, and will continue until the position is filled. The position will be subject to budgetary approval. We thank candidates in advance for their applications; however, only the short-listed candidates will be contacted. Please indicate in your application if you are a Canadian citizen or a permanent resident of Canada.
