The applicant should demonstrate strong evidence of leadership and excellent communication and organizational skills.

## Responsibilities

The Deputy Director of PIMS will work, in collaboration with the PIMS Director, the PIMS Central Team, and others across the PIMS network, to advance the mathematical sciences. In particular, the Deputy Director's portfolio includes: the development and implementation of scientific policies; the adjudication process for educational, industrial and scientific programs; the organization of institute activities; the supervision of staff; and the preparation of grant proposals. The Deputy Director will have considerable autonomy and will serve ex-officio as a member of the PIMS Scientific Review Panel and the PIMS Board of Directors. The Deputy Director will continue to serve as a Professor at a PIMS member university. PIMS will provide funds to assist with a reduction in teaching load and a salary topup.
